PURPOSE OF COMMITTEE

Diane Simbro said the Nominations/Recruitment Committee was formed for the purpose of recruiting members to the Workforce Development Board and to seek individuals for nomination as officers of the Board. Member were provided information regarding current Board membership, Board Committee Structure and Local WDB Membership Requirements. Diane reviewed the information provided. She explained that the majority (51%) of the members of the Board must be private business members. She said the Board currently meets this requirement; however, it has several inactive members and needs to recruit more individuals. She explained that there were additional rules to choosing Board members. Board members must be owners of businesses or business executives with policy-making or hiring authority. Members should also represent businesses of the local areas in-demand industry sectors or occupations. (DWD Issuance 12-2016 Change 1)

Pat Poepping provided a series of maps showing the WDB's current member representation by county of private business members, public members and Chief Local Elected Officials.
