Good morning everyone,

First of all, a friendly reminder - Deadline is today for those who have not responded. We need your vote on the policies we sent out last week in case we need to make additions or corrections. These will have to go out for public comment on the 14th along with the Local Plan that you will find attached.

For those of you who have not participated/voted on the Board's Local Plan, every four years we are required by law to create a new Local Plan. The Office of Workforce Development sends us a template and we have to respond to each section. We are to gather information from our One-Stop partners, board members, CLEOS, economic development leaders, educators and others to create this plan. The attached plan is a combined effort of subject matter experts who contributed information. After we receive your vote of approval, we will post this plan for public comment on our website and send to our required partners. After the public comment period, the Local Plan will go to the Office of Workforce Development for approval. Our office is audited by the Office of Workforce Development at least annually and the United States Department of Labor performs reviews as needed. They use this as a tool to gauge our progress in all of the areas listed in the Plan.

You will notice there are numerous sections that state there are attachments. I did not attach them to the plan as these are the documents you received last week for approval.

Please see the Transmittal Form for you to sign to indicate your approval or disapproval. The ones who are cc: do not need to reply.

This has to be posted on February 14, so I will need your response by February 13.

Thanks to all of the contributors to the plan. Your input is greatly appreciated.
