MEETING CALLED TO ORDER

Chairperson Annette Sweet called the April 14, 2020 Northeast Missouri Workforce Development Board (NEMO WDB) Nominations Committee Meeting to order at approximately 1:00 p.m. The meeting was conducted electronically.

ROLL CALL

Roll call was taken. Four Committee members were present, and a quorum was established. CLEO Chairperson Glenn Eagan was also present.

APPROVAL OF AGENDA and MINUTES

Committee members unanimously approved the Agenda and the June 3, 2019 Meeting Minutes.

DISCUSSION OF SLATE OF OFFICERS FOR PY 2020

The members discussed possible candidates for nomination as WDB Officers. Diane said she would speak with Janice Robinson to ask if she would be willing to accept the nomination of Secretary/Treasurer. She also agreed to speak with Darin Arnsmeyer to ask if he would be willing to accept the nomination as Board Chair. After further discussion, the members voted on the following list of three individuals as possible candidates for Board Vice-Chair nomination: Michael Purol, Allie Bennett and Les Cardwell. Corey agreed to contact Michael Purol to ask if he would be willing to serve.

It was stated that the Committee may need to have another meeting if these individuals were not willing to serve.

UPDATE ON PRIVATE BOARD MEMBER CANDIDATES

Annette felt individuals may be more willing to serve if they were contacted by their County Commissioner. Diane said if the Committee could suggest possible candidates, the County Commissioner could then be the one to ask them. She said currently the Board membership was in compliance. However, a few of the current members do not participate and should be replaced. She noted that two private Board Members,

Kami Mohn and Diane Noah, had resigned. It was noted that Allie Bennett had replaced Kami at Northeast Power and the Committee felt she would be a good candidate for Board membership. Corey agreed to share her contact information with the Board staff so she could be contacted. Diane said another possible candidate was Stephanie Cooper with Douglas Community Services. She said Stephanie was very interested in Workforce Development and was interested in serving on the Board.

The need to recruit members in the counties that were not represented was also discussed. Diane said she would send the members a list of the current Board Members and the counties and sectors they represented.

JoAnn agreed to contact the County Commissioners and other individuals in Warren and Lincoln Counties to see if they had any suggestions for candidates. Shari said she would contact a health care provider in Scotland County to see if they may be willing to serve. She also agreed to review the member list of the Leadership Northeast Program to see if there were any possible candidates there. Glenn said he would speak with Joe Rubison to try and get him to attend more regularly.

The meeting adjourned at approximately 1:35 p.m.
