Dear Dr. Leathers:

The Northeast Missouri Workforce Development Board and CLEOS voted electronically to approve the request for the transfer of Dislocated Worker Funds to Adult Funds. Thirteen (13) Board Members voted Yes. Zero (0) voted No. Six (6) CLEOS voted Yes. Zero (0) voted No.

I have attached the letters that were sent to explain the actions needed.

- (1) Your approval is needed to approve the request to transfer \$100,000 from Dislocated Worker funding to Adult funding. We have \$16,325.65 in FY20 Adult Funds that has to be spent by June 30, 2021 and we have \$171,674.97 in FY20 Dislocated Worker Funds that has to be spent by June 30, 2021. We will not be able to spend that amount of Dislocated Worker funding by June 30, 2021 so we risk losing that funding if we do not utilize the ability to transfer up to 100% of the funding from Dislocated Worker to Adult. We have \$236,900.14 in Adult Funds that must be spent by June 30, 2022 and \$321,968.00 in Dislocated Worker Funds that must be spent by June 30, 2022 so we are in a good position to transfer this money without risking services to the dislocated workers.
